# Appendix 1: President's Report

In general this has been a very good year for chess in BC. All of our major tournaments have seen record or near-record attendance, and several new events have emerged (Nanaimo tournaments, Victoria Open, Semiahmoo Open). Factors contributing to the increased tournament participation include the continuing influx of ambitious and well-trained juniors from establishments such as the Vancouver Chess School and other area coaches; the return to competitive chess, sometimes after many years, of players who are past the challenges of career and family and have time to take up the game again; and not least the availability of quality events, spearheaded mostly through the efforts of Victoria Chess.

Financially the BCCF is doing well; expenses were higher than expected, mainly due to renewing the website hosting for the next three years, but revenues were also higher, resulting in a healthy surplus. Major ongoing expenses were the funding of the BC Closed and subsidies to most of the other championships and an honorarium for the bulletin editor; last year \$600 was budgeted to support local chess but only a small portion was spent – we can definitely increase our spending in this area without harming our overall financial health.

Areas of concern? There are a limited number of organizers and tournament directors, the latter being a particular issue on Vancouver Island. We are taking measures to train more arbiters through the use of seminars and apprenticeships, but this still remains an issue as our current organizers and TDs advance in years. Elsewhere in the province there are a few bright spots in Bowser, Nanaimo and Williams Lake, but activity outside of Victoria and the Lower Mainland remains limited or non-existent in comparison to previous times. Such initiatives as do exist need to be supported and nurtured. One possible means of doing this might be through internet matches, whether informally or as a province-wide league.
